

ORDER

WHEREAS for the Procurement of **Embankment/Pond Excavation Rawalpindi (Site -III)** through Tender Enquiry No. PC/DF(H.M)7HATCH-V/2022-23 was invited through advertisement in two daily newspapers (Daily Express & Dawn) as well as on websites of PPRA & DOF.

AND WHEREAS the Technical & Financial Bids of the same were opened on 03-01-2023 & 10-01-2023, respectively.

AND WHEREAS M/S Abbas Construction Co., Canal Road, Near Muhalla Mustoi, Fazilpur, District Rajanpur participated in tender and offered lowest price of Rs.10,20,000/- against above said tender enquiry.

AND WHEREAS the Advance Acceptance (AA) of above referred tender was issued in favour of the said firm vide this office letter No.PC/DF(H.M)7HATCH-V/2022-23/44 dated 23-01-2023. The said firm was required to deposit the Security/Performance Guarantee of Rs.1,02,000/- and stamp paper of Rs. 1000/-. Several communications were made telephonically repeatedly and vide this office letter Nos. PC/224 dated 15-02-2023 and PC/373 dated 17-03-2023 to deposit the said security alongwith stamp duty, but said firm failed to deposit the security/guarantee & Stamp Paper in due course of time. Resultantly, this department have to cancel the above referred tender vide this office letter No.PC/430 dated 17-04-2023.

AND WHEREAS the show cause notice was served to **M/S Abbas Construction Co.** vide this office letter No. PC/446 dated 20-04-2023 and directed to submit written reply within seven (7) days but the firm failed to submit its reply.

AND WHEREAS a notice for Personal Hearing was issued to the said firm vide this office letter No. PC/488 dated 08-05-2023 and directed to appear on 16-05-2023 at 11:30 a.m. with its written reply before the undersigned. The representative of the said firm did not attend the scheduled Personal Hearing & telephonically requested to reschedule the Personal Hearing on 25-05-2023 at 10:00 a.m. Therefore, another notice for personal hearing was served by this office vide letter No. Pc/516 dated 18-05-2023.

AND WHEREAS Mr. Ghulam Abbas Mustoi representative of firm M/S Abbas Construction Co. attended the hearing in person on 25-05-2023 and submitted written statement, in which the representative emphasised that due to economic condition of the country the prices of fuel has been increased sharply and inflation rate

is too high resultantly, the cost of excavation/embankment has become doubled as compared to the rate offered by the firm. Therefore, it is difficult to complete the above said work as per offered rates by our firm. The representative, **Mr. Ghulam Abbas Mustoi** has requested that foregoing now the rates may be re-estimated according to the current situation for the said work.

Now therefore, I **Dr. Sikender Hayat, Director General Fisheries, Punjab** being the Competent Authority, in exercise of powers conferred under Rule 21 of Punjab Procurement Rules 2014 (amended time to time), after perusing the relevant record and hearing the representative of said firm during the course of personal hearing, do hereby black list and debar the firm **M/S Abbas Construction Co., Canal Road, Near Muhalla Mustoi, Fazilpur, District Rajanpur** from participating in any public procurement of this Agency for a period of one (01) year with immediate effect.

Note: the firm may prefer a representation, within 30 days, before Managing Director of the Punjab Procurement Regulatory Authority.
