## EXPRESSION OF INTEREST (EOI)

The Department of Fisheries, Government of the Punjab, intends to invite EOI proposals from Registered Consultancy Firms for prequalification to conduct survey / census of fisheries and aquaculture sector of Punjab under Development Project titled Pilot Shrimp Farming Cluster Development Project. The estimated cost of this consultancy is Rs. 18,000 Million.

The interested firms/companies should have sufficient experience in the relevant field / discipline with the following information / documents demonstrating that they have the required qualifications and relevant experience.

1. Copy of Registration with FBR(NTN).
2. Proof of GST Registration, PRA (PST).
3. Registration with SECP/ Registrar of firm.
4. Registration with relevant professional body, if any.
5. A certificate/ affidavit that the firm is not blacklisted by any Government/ Autonomous Body/ Organization.
6. Any other supporting document.

The firms/ companies / JVs/ Consortiums will be selected in accordance with procedure / method set out in the PP Rules, 2014 (amended time to time). Department of Fisheries, Punjab reserves the right to reject all proposals as per Rule 35 of PP Rules, 2014 (amended time to time).

The proposal of EOI must reach to the Purchase Cell of Department of Fisheries, Punjab, 9-A Bahawalpur Road Chauburji Lahore by registered post / courier or delivered upto 11:00 A.M. on 28.02.2022. The EOI Proposals will be opened on the same date i.e 28.02.2022 at 11.30 A.M in the presence of representatives of the firms.
