In case of any holiday announced by the Government (due to any reason) the tenders will be opened on next working day on same time with same terms & conditions.
4. Tender must be submitted on prescribed forms available with the Purchase Cell o/o Director General Fisheries, 2-Sanda Road, Lahore on Cash Payment mentioned against each (non-refundable).
5. All the firms must attach Bid Security/ Earnest Money with financial bids @ 2% of the total value of the quoted price in shape of Call Deposit in favour of the Director General Fisheries, Punjab, Lahore from any Scheduled Bank.
6. The offers should be valid minimum for 90 days and the quoted price must include all kinds of Taxes (GST/Income Tax, Duties and Freight/Transportation charges etc.) upto consignee's end. All terms and conditions of PPR, 2014, Government of Punjab, S&GAD will apply.
