General Conditions

1. The supplier firm must be registered with Sales Tax/Income Tax Department and quote their GST/NTN numbers etc.
2. The rates must be offered according to detail/instructions of Tender Enquiry.
3. Tender documents containing terms & conditions and detailed specifications of required items can be obtained, **“immediately”** on payment of the cost of the document (non-refundable) mentioned against each item from the Purchase cell o/o Director General Fisheries Punjab, 2-Sanda Road, Lahore during the working hours **8:00 to 15:00**.
4. The last date for sale of tender documents is **28-12-2016**. Tender / bids will be received upto **2:00 P.M** on **30-12-2016** and will be opened at **3:00 P.M** on **30-12-2016** in the office of **Director General Fisheries, Punjab, 2-Sanda Road, Lahore** in the presence of the bidders or their representatives. In case of any holiday announced by the Government (due to any reason) the tenders will be opened on next working day on same time with same terms & conditions.
5. All the firms must attach Bid Security/ Earnest Money with Financial bids @ **2% of the total estimated price of each item mentioned in the tender documents** in shape of Call Deposit in favour of the Director General Fisheries, Punjab, Lahore from any Scheduled Bank.
6. Procumbent shall be governed by the Punjab Procurement Rule 2014.
7. **“Single Stage Two Envelopes”** bidding procedure (Technical and Financial) as per Rule 38 (2) (a) of PPRA Rule 2014, shall be applied.
 - i) Tender shall be submitted comprising a single package containing two separate envelopes. Each envelop will contain separately the financial proposal and the technical proposal.
 - ii) Envelope shall be marked as **“Financial Proposal”** and **“Technical proposal”** in bold and legible letters to avoid confusion. The financial proposal envelop will only be opened after Technical approval as per PPRA Rules 2014.
 - iii) On rejection of technical proposal the financial proposal will be returned unopened. This department will not be responsible for any opening of financial proposal, where it is submitted collectively for all the items, or found opened on submission or not properly sealed.
8. The offers should be valid minimum for 60 days and the quoted price must include all kinds of Taxes (GST/Income Tax, Duties and Freight/Transportation charges etc.) upto consignee’s end. All terms and conditions of PPR, 2014, Government of Punjab, S&GAD will apply.

9. Department reserves the right to reject all tenders before issuance of Advance Acceptance (as per provision of Rule 35 of PPR, 2014).
